

## \$12,000 Michael T. Martin Scholarship Application

### THE AGC:

The Associated General Contractors, Las Vegas Chapter is a nonprofit construction trade association of some 500 member companies, both union and open shop, throughout the Las Vegas valley. AGC assists member companies with insurance benefits, safety programs, labor relations, public relations and networking opportunities, legislative involvement, representation and training education programs and community service projects. ### THE AWARD:

AGC will award a \$12,000 scholarship to a graduating senior from a high school located within Clark, Nye, Esmeralda or Lincoln counties. AGC's Scholarship Committee will review all applications received by deadline and select the student who exemplifies leadership, integrity, creativity, dedication and studiousness along with a desire to enter a career in construction. Scholarship recipient must attend eight consecutive semesters at an accredited four-year college or university beginning the fall after high school graduation. Failure to do so may result in forfeiture of scholarship monies. The AGC Scholarship Committee may waive this requirement should extenuating circumstances warrant.

### THE STEPS:

1. Complete the enclosed scholarship application and other requirements and return to AGC- c/o Mandi Lindsay, 150 N. Durango Drive, Suite 100 - Las Vegas, Nevada 89145, on or before the **April 6, 2012** deadline. Applications may also be hand delivered to this location. Absolutely no late applications will be accepted.
2. Finalists will be required to interview with the AGC scholarship committee, and will be notified either by mail or telephone on or about **May 18, 2012**. Interviews will be conducted within three weeks of notification.
3. Finalists will be notified of the AGC scholarship committee's decision by mail on or around **June 22, 2012**

## 5. SCHOLARSHIP TIMETABLE – IMPORTANT DATES

### FALL 2012

1. The recipient must send verification of acceptance to an accredited four-year university or college, proof of enrollment for at least 12 credits along with evidence that recipient's construction-related major is officially recorded with the school of choice. These three items must be submitted to the AGC by **August 1, 2012**. If unable to comply with these requests, recipient must contact AGC at 702-796-9986 to make other, suitable arrangements or scholarship will be withdrawn.
2. Upon receipt of requested documentation, a check in the amount of \$1500 will be made payable to the recipient and mailed to the address provided on the application by **August 20, 2012**.

### SPRING 2013

1. To remain eligible for the scholarship recipient must mail a copy of university transcript indicating a 2.0 grade point average and that the recipient earned **12 or more credits fall semester 2012**. Verification must also be sent indicating the recipient is enrolled for **12 credits in spring semester 2013**, by **December 31, 2012**.
2. Upon documentation approval, a check in the amount of \$1500 will be made payable to the recipient and mailed to the address provided on the application by **January 15, 2013**.

### FALL 2013

1. To remain eligible for the scholarship recipient must mail a copy of university transcript indicating a 2.0 grade point average and that the recipient earned **12 credits the spring semester 2013**, as well as verification that recipient is enrolled for **12 credits in fall semester 2013**, by **August 1, 2013**.
2. Upon receipt of requested documentation, a check in the amount of \$1500 will be made payable to the recipient and mailed to the address provided on the application by **August 20, 2013**.

### SPRING 2014

1. To remain eligible for the scholarship recipient must mail a copy of university transcript indicating a 2.0 grade point average and that recipient earned **12 credits fall semester 2013**, as well as verification that recipient is enrolled for **12 credits in spring semester 2014**, by **December 31, 2013**.
2. Upon documentation approval, a check in the amount of \$1500 will be made payable to the recipient and mailed to the address provided on the application by **January 15, 2014**.

### FALL 2014

1. To remain eligible for the scholarship recipient must mail a copy of university transcript indicating a 2.0 grade point average and that the recipient earned **12 credits spring semester 2014**, as well as verification that recipient is enrolled for **12 credits in fall semester 2014**, by **August 1, 2014**.
2. Upon receipt of requested documentation, a check in the amount of \$1500 will be made payable to the recipient and mailed to the address provided on the application by **August 20, 2014**.

### SPRING 2015

1. To remain eligible for the scholarship recipient must mail a copy of university transcript indicating a 2.0 grade point average and that recipient earned **12 credits fall semester 2014**, as well as verification that recipient is enrolled for **12 credits in spring semester 2015**, by **December 31, 2014**.
2. Upon documentation approval, a check in the amount of \$1500 will be made payable to the recipient and mailed to the address provided on the application by **January 15, 2015**.

### FALL 2015

1. To remain eligible for the scholarship recipient must mail a copy of university transcript indicating a 2.0 grade point average and that the recipient earned **12 credits spring semester 2015**, as well as verification that recipient is enrolled for **12 credits in fall semester 2015**, by **August 1, 2015**.
2. Upon receipt of requested documentation, a check in the amount of \$1500 will be made payable to the recipient and mailed to the address provided on the application by **August 20, 2015**.

### SPRING 2016

1. To remain eligible for the scholarship recipient must mail a copy of university transcript indicating a 2.0 grade point average and that recipient earned **12 credits fall semester 2015**, as well as verification that recipient is enrolled for **12 credits in spring semester 2016**, by **December 31, 2015**.
2. Upon documentation approval, a check in the amount of \$1500 will be made payable to the recipient and mailed to the address provided on the application by **January 15, 2016**.
